- Using wool insulation in the premisses
- Encouraging staff to use public transport, cycle or walk to commute to work.
- Encouraging car sharing when staff is working away from the studio.
- Encouraging the use of green solvents

 - Sharing resources and bulk order materials to ensure efficient use of materials and limit transport impact
 - Sourcing materials from local business when possible

- Supporting charitable enterprises through its supply chain and through donating excess materials to the local Children's Scraps store
- Hosting student work placements from local schools helping to build community links
